

Open Competitive Examination for Recruitment to the Post of Electro-Medical Technician

Applications are invited from qualified applicants for existing 64 vacancies in the post of Electro-Medical Technician in the Management Assistant Technical Segment – 03 Service Category of the Ministry of Health and Mass Media and the hospitals and institutions under its purview.

2. Required Qualifications

2.1. Educational and Vocational Qualifications

2.2. Experience: Experience gained in the relevant field from any Government institution or recognized private sector institution will be considered an additional qualification for the post of Electro-Medical Technician.

2.3. Physical Fitness: Every candidate should possess sufficient physical and mental fitness to serve in any part of Sri Lanka and to perform the duties of the post.

2.4. Other:

I. Should be a citizen of Sri Lanka.

II. Should be of excellent character.

III. All the qualifications specified under Sections 2.1 to 2.5 required for recruitment to the post should have been fully satisfied in every respect as at ~~12.10.2026~~

2.5. Age:

05. Terms of Engagement in Service

- (i) The officers who are recruited shall be willing to serve any part of the island.
- (ii) The post you are appointed to is permanent. You are subject to policy decisions made by the Government in future regarding the pension scheme the selected candidates are entitled to. Further, you shall contribute to the Widows' and Orphans' Pension Fund / Widowers' and Orphans' Pension Fund. You shall pay your contribution as prescribed by the Government from time to time.
- (iii) This appointment is subject to a probationary period of three years, and the first Efficiency Bar Examination shall be passed within three (03) years from the date of recruitment.
- (iv) Proficiency in relevant official language shall be acquired within five (05) years from the date of appointment as per the Public Administration Circular No. 18/2020 and other circulars incidental thereto.
- (v) This appointment is subject to procedural rules of the Public Service Commission, Establishments Code of the Democratic Socialist Republic of Sri Lanka, Financial Regulations of the Government, provisions in circulars issued by the Government, the recruitment procedure to the post of Electro Medical Technician- management Assistant Technical Segment 03 and circulars and General provisions issued by the Secretary to the Ministry of Health and Mass media from time to time.
- (vi) The medium you are appointed shall be the medium specified by you in the application.

06. Method of Application

- (a) Applicants should prepare their applications in accordance with the specimen application attached hereto and indicate "Recruitment to the Post of Electro-Medical Technician in the Management Assistant Technical Segment – 03 Service Category of the Ministry of Health and Mass Media (Open) – 2026" on the top left-hand corner of the envelope containing the application and send it by registered post to the Secretary, Ministry of Health and Mass Media, Admin 07, No. 106, Dudley Senanayake Mawatha, Colombo 08 before ~~12.10.~~ 2026
- (b) The closing date of application is : ~~12.10.~~ 2026
- (c) The examination fee is Rs. 1,000.00. This amount should be paid at any branch of the Bank of Ceylon to be credited to Account No. 7041318 maintained in the name of the Secretary, Ministry of Health and Mass Media, at the Thaprobhan Branch of the Bank of Ceylon, and the receipt obtained should be firmly affixed within the space provided in the specimen application. The examination fee will not be refunded for any reason or considered valid for any other examination or purpose. It is also advisable to retain a copy of the application and the receipt for the payment. (Money orders and stamps will not be accepted.)
- (d) When preparing the application, the name of the examination stated in the heading should be given in English in addition to Sinhala in applications prepared in Sinhala, and in English in addition to Tamil in applications prepared in Tamil.
- (e) Any alterations are not considered after forwarding applications.

07. Identity of Candidates

Candidates shall prove their identity to the satisfaction of the Supervisor of the Examination Hall for each subject they sit in the examination hall. Any of the following documents will be accepted for this purpose.

- I. National Identity Card
- II. Valid Passport
- III. Valid Sri Lankan Driving License

Furthermore, candidates shall enter the examination hall without covering their face and both ears so as to verify their identity. Candidates who refuse to prove their identity so will not be permitted to enter into the examination hall. Further, from the moment of entering the examination hall till leaving after the examination, candidate shall not cover the face and both ears enabling the Examination Authorities to identify the candidate. Any other instructions relating the examination will be notified through the admission card. Similarly, the Supervisor of Examination has the authority to refuse admission or remove from the examination hall any candidate who fails to comply with these terms.

08. Attestation of Signature

The signature of the applicant should be certified by a Principal of a Government school, a Justice of the Peace, a Commissioner for Oaths, an Attorney-at-Law, a Notary Public, a commissioned officer of the Armed Forces, a gazetted officer of the Police Service, or an officer in the staff grade holding a permanent post in the Sri Lanka Administrative Service/ Sri Lanka Educational Administrative Service/ Government Accountants' Service/ or holding a permanent Government post with a basic annual salary exceeding Rs. 854,880/-.

09. Providing False Information

Applications shall be carefully furnished with accurate information. If any information furnished by any candidate is found to be false before the appointment, his/ her candidature will be cancelled. If any such information is disclosed after the appointment, action will be taken to dismiss the candidate from service subject to relevant legal action.

10. Conditions of the Examination:-

- I. All the required qualifications for the post shall be fulfilled as at .1.2.2026. The applicants who have not secured prescribed qualifications are not eligible for the appointment even though they obtain adequate marks in the examination.
- II. The applications which are not prepared in compliance to the specimen form appended hereto and incomplete applications are rejected without any notification.
- III. Receipt of application will not be acknowledged and applications received after closing date will not be accepted.
- IV. Applicants who have submitted duly completed applications will be called for the competitive examination on the assumption that only those who possess the qualifications specified in the Gazette Notification have applied. The applicants will be informed accordingly at the address stated in the application.
- V. The competitive examination for recruitment consists of two parts, namely the Written Examination and the Practical Vocational Test.
- VI. The Written Examination will be conducted first, and from among the candidates who pass it, twice the number of candidates intended to be recruited will be called for the Practical Vocational Test in order of merit based on the marks obtained by them. Candidates who pass the Practical Vocational Test will be called for the interview in order of merit based on the total marks obtained at the Written Examination. From among them, candidates who have fulfilled the required qualifications will be selected, and the candidates so selected will be appointed to fill the vacancies in the Ministry of Health and Mass Media and the hospitals and institutions under its purview.
- VII. The examination will be held in Sinhala, Tamil and English mediums. Candidates may sit the examination in any one of the mediums of their choice. Once selected, the medium of language shall not be changed subsequently. Candidates shall answer all question papers of the examination in the same medium.

N.B.:-

- a) The applicant should ensure that every section of the application has been completed and that the information provided is accurate.
- b) The applications of the applicants, who fail to furnish relevant documents thereto when requested, will not be entertained. Applicants shall not annex any document or copy which is not relevant to the application.
- c) Complaints on a loss of application or a letter related in the post will not be entertained. Any loss or damage that may arise due to delaying the submission of applications until the closing date shall be borne by the applicants themselves.
- d) The number of candidates to be called for the interview, the number of candidates to be appointed to the posts, and the effective date of the appointments shall be determined by the Appointing Authority. The Appointing Authority reserves the right not to fill any or all of the vacancies.
- e) If any issue arises regarding any matter relating to the recruitment to this post, whether covered or not covered by this Gazette Notification, the decision of the Secretary to the Ministry of Health and Mass Media shall be the final decision. In the event of any discrepancy, inconsistency or contradiction among the Sinhala, Tamil and English texts of this Notification, the Sinhala text shall prevail.
